Exemption of Freight Charge.

Sir,

Please refer to your Memo No. 111/RMDD dated 02.05.2012. Reference is also drawn to your Cabinet Memo No. 23/RM&DD dated 19.04.2012 and the decision of the Cabinet meeting held on 20th April 2012 duly approving the proposal of your Department for waiver of supervision charges, taxes etc. in respect of revised design of the "Reconstruction of Earthquake Damaged Rural Houses" (REDRH) project.

In pursuance of the above mentioned decision of the Council of Ministers, it is hereby conveyed that SNT will waive the supervision charges on the materials (TMT Bar and Cement) to be procured for the reconstruction of earthquake damaged houses.

However, we would also like to caution you that in the past, instances have arisen where benefits of waiver of supervision charges have not percolated to the consumers/final beneficiaries. Therefore, it is advisable to

ensure that the supplier quotes prices duly showing various components such as supervision charges and other taxes, duties, royalties which are proposed to be exempted. This will enable the Department to deduct the exempted component at source while making payment.

I am enclosing a copy of Transport Department's Notification No. 729/GOS/TD/2011-12/8 dated 28.06.2012 relating to freight charges. The freight rate applicable to your Department is  $\gtrless$  8.90/KM/Ton which is inclusive of supervision charges @  $\gtrless$  2.20/KM/Ton and the net payable to the transporter is  $\gtrless$  6.70/KM/Ton.

#### NOTIFICATION

In supersession of Notification No. 23/T dated 03/12/2010 and Notification No. 16/T dated 30/01/2012, it is hereby notified that the State Government has decided to prescribe the following freight rate for goods transported by SNT, either under direct supervision or otherwise as follows:

### A. Goods Transported by Truck:

- 1. ARMY & GREF:
  - (a) Intra-State (Within Sikkim) ₹ 12.40/Km/Ton
  - (b) Inter-State (Siliguri/NJP to Sikkim) ₹ 11.00/Km/Ton
- 2. Hydel Project Developer, Paramilitary Forces ₹ 11.20/Km/Ton (Inter/Intra-State)
- 3. General Public excluding sl no (1) & (2) above ₹ 8.90/Km/Ton (Inter/Intra-State)
- B. Goods Transported by Tanker (POL Products):
- 1. ARMY & GREF:
  - a) Intra-State (Within Sikkim) ₹ 10.65/Km/KL
  - b) Inter-State (Siliguri/NJP to Sikkim)) ₹ 10.35/Km/KL

- 2. Hydel Project Developer, Paramilitary Forces ₹ 11.20/Km/KL (Inter/Intra-State)

## Terms & Conditions:

- 1. Service Tax (inclusive of Education Cess, Secondary Education Cess) @ 12.36% of 25% Gross amount shall be charged extra unless otherwise specifically agreed upon.
- 2. Levy of supervision charge shall be:
  - ₹ 3.10/Km/Ton against ₹ 12.40/Km/Ton rate.
  - ₹ 2.60/Km/Ton against ₹ 11.00/km/Ton rate
  - ₹ 2.80/Km/Ton against ₹ 11.20/Km/Ton rate
  - ₹ 2.20/Km/Ton against ₹ 8.90/Km/Ton rate
  - ₹ 2.65/Km/KL against ₹ 10.65/Km/KL rate
  - ₹ 2.60/Km/KL against ₹ 10.35/Km/KL rate
- 3. Minimum chargeable rate in case of voluminous load shall be 8 MT and minimum distance 20 KM. Where the load is higher than 8 MT, it should be charged as per actual weight.
- These rates shall be effective from 1<sup>st</sup> of July 2012.
