Sir,

Reference is drawn to letter no 304/RM&DD/M dated 6th March, 2013, (copy enclosed) wherein this office had requested that external electrification to the REDRH (reconstruction of Earthquake damaged Rural Houses) be provided under the RGGVY Programme. I am to again re-iterate the request for convergence as this would greatly benefit the beneficiaries whose houses had been damaged during the earthquake of 11th September, 2011. As of date 7972 beneficiaries have been identified and around 2000 houses have been completed.

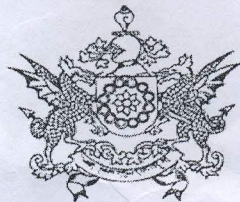
Further , I would like also to inform you that the State Government is in the process of building Rural houses under the Chief minister's Rural Housing Mission (CMRHM) for the BPL households. AS of date 6000 beneficiaries have been identified under this programme and around 2000 houses have been completed. Therefore, we would like to request you to kindly explore convergence of RGGVY with both the above housing programmes.

In view of the above, we would like to request you to kindly direct your district level functionaries to coordinate with the office of the ADC (Dev) for closer coordination and operationalising this convergence at the earliest. A copy of the letter to the districts may be endorsed to this office for follow up from our end.

Subject: Convergence of the REDRH Project with the RGGVY Programme

Sir,

As you are aware, RM&DD is implementing the Reconstruction of the Earthquake Damaged Rural Houses (REDRH) Project funded under the PM's Special Relief Package. The Operational Guidelines (Enclosed – Para 6.6) of the REDRH provides for convergence with the RGGVY Programme for electrification. Under this project, the target is to complete 7,972 houses, of which till date 5,784 beneficiaries have been finalized and the detailed list is enclosed (North: 1745, East: 1779, South: 911, West: 1349).

The RGGVY Programme needs to provide external electrification to these houses, while internal electrification will be taken up under the REDRH Project. The urgency of this convergence was also reiterated in the meeting of the State Level Vigilance and Monitoring Committee Meeting chaired by the Hon'ble Minister – RM&DD on 5th Feb, 2013 (minutes enclosed).

We would be grateful if you could direct your District level functionaries to coordinate with the office of the ADC(Development) for closer coordination and operationalizing this convergence at the earliest.
